# OVERVIEW

PHANTOM™ has been specifically designed and tested for a curing process using natural outdoor strong sunlight, or in conjunction with PHANTOM Cure Station™. Please read the PHANTOM™ DIY application instructions and warnings before beginning.

In Northern and Southern latitudes mid-Winter, or where 1 hour of uninterrupted strong sunlight is not possible, it is recommended to cure in a PHANTOM Cure Station™, or apply between Spring and Fall when the sun is strongest for proper UV strength and temperature.

**Disposal:** If entire contents of individual packets are not used up, remaining liquid can be poured into absorbent cloth or paper and disposed of once entirely dry. 




## HOW TO APPLY PHANTOM:

PHANTOM requires a minimum of 1 hour of direct sunlight, and temperatures above 0°C/32°F to cure each part properly. Direct sunlight is required for a proper cure. Cloud cover of any type is unacceptable.

Set up one work station away from direct sunlight. Set up a second work station as a curing zone in direct sunlight.



Apply in a well ventilated area and wear protective gloves during the process. Wear eye and face protection as needed for particulate.




### STEP 1

Clean the base either by a fresh stone-grind or a thorough base cleaning. A base grind is highly recommended if the base is at all oxidised and/or has bad structure and damage. This is essential to help ensure good PHANTOM performance. If the bases are in good shape simply use base cleaner to remove old wax and grime. Apply liberally. Spread with a paper towel until base is fully covered and continue to wipe clean. Wipe dry with a clean microfiber towel, allowing full evaporation of base cleaner afterwards. If base is particularly dirty brush it out, and then repeat base cleaning process.

## STEP 2


**IMPORTANT:** PHANTOM should be at ambient room temperature (65°F - 85°F / 18°C - 30°C). Skis will each use one packet of A and B per each ski base. Snowboards will use both packets of A and B for the entire base.




Thoroughly knead each packet to mix the contents before application. If you feel any harder crystals in the packet continue to mix.

Apply liquid from Packet(s) A only as a line down the center of the ski/board. Applying light pressure with applicator pad, spread evenly between the contact points, working from the centre of the ski out to the edges (to minimise mess and clean-up later). Spread PHANTOM out to tips and tails, trying to minimise run off. Wipe off any excess PHANTOM that spills over onto the top sheet.

Note: For best results, warm up the bases in the sun before applying PHANTOM.



## STEP 3




Place ski(s)/snowboard on a flat surface (out of direct sunlight) for a 15 minute soak period. After the soak period, wipe down the base vigorously with a clean paper towel. The aim should be for the ski to have a polished sheen, with no pools of excess PHANTOM. This wipe down is key for getting complete and timely cures. Clean any excess PHANTOM that has dripped onto the top sheet or edges with a damp rag or alcohol wipe before it has been set out to cure. PHANTOM can leave a stain on top sheets if left on. A WD-40 type cleaner/degreaser can help remove a stain. Or wiping down with a very hot wet rag.

## STEP 4

Bring skis or snowboard to outside curing location and allow Part A to cure under direct sunlight for a minimum of 1 hour. A full cure has been achieved when the base is fully dry with light PHANTOM residue (chalky white). If wetness exists, wipe off with a paper towel and continue curing until fully dry.

Note:

- If the weather changes after 30 minutes or you fail to achieve a full cure, remove as much of the wet residue as possible with a paper towel and bring inside to your warmest room for 24 hours.
- Product should lay horizontal for at least the first 20 minutes, and then can be angled to maximize and follow direct sun exposure.




## STEP 5

Make sure that the skis or board are completely dry. If any wetness exists, continue to cure and DO NOT proceed further in the process. If you pull the skis or board prematurely and move on to the next step, you may not achieve desirable performance. If you are unsure if a patch is wet, you may test it by swiping the area with a rubber glove and seeing if any oily residue is left on the glove.

**Please note: If you pull the skis or board prematurely and move on to the next step, you may not achieve desirable performance.**

Wear appropriate eyewear and mask to avoid flying particles. If you have access to one, a nylon roto brush is optimal for this step. Otherwise, use your own hand nylon (or horsehair) brush. Vigorously brush the base from tip to tail until base looks its natural color with no visible white cured PHANTOM. Spray water over the entire base. Wipe off with a clean microfiber until dry.



## STEP 6

On a dry base repeat Step 2 - 6 with Part B. Note that when initially spreading PHANTOM Part B over the base, it may pill/bead up. If this occurs, continue to spread/massage the PHANTOM Part B into the base until you see an even distribution.

## **STEP 7**

Following the finishing/brushing process for Part B, spray water over the entire base once again. Polish the bases with the supplied fiber polishing pad and water. Apply solid pressure, and polish in the same motion as you would use a hand brush. At this point, the ideal base appearance is matte black.

If necessary do a final top sheet clean using WD-40 and a paper towel, rubbing vigorously. Then clean with rubbing alcohol. Once alcohol is dry if you cannot see any PHANTOM stains move on to cleaning side wall and edges. If further cleaning is needed, use a wire brush lightly in a circular motion with WD-40 until the stains are gone. Check the stains are fully gone using rubbing alcohol once again.

## **STEP 8**

A PHANTOMed base will continue to have consistent and fast glide, for as long as the base is kept in good condition. In practice, this means that some maintenance is required at regular intervals.

When the bases begin to look dry/white, this is a sign that abrasion has formed micro-hairs on the base. These can be managed through periodic polishing with the provided pad.

If the structure of the bases becomes damaged or severely abraded, a base grind is recommended. A base grind should always be followed by polishing to reduce microhairs.

Spring time dirt and grease also needs to be regularly cleaned from the base structure. Clean with an approved base cleaner, followed by nylon brush and polishing with pad.

### Best Practices:

- Avoid direct UV light on PHANTOM, except for curing.
- Use protective gloves to avoid contact with skin.
- PHANTOM is harmful if ingested. Clean up spills and keep away from children and pets.
- Wear protective eyewear and mask while brushing.
- Apply in a well ventilated area
- Late Spring through Summer is the best time for outdoor curing. Prepare accordingly and be aware of solar strength in your location during other parts of the year.

Note: If you notice the consistency of the Phantom has thickened considerably to a gel or other similar substance, notify us immediately and avoid use on skis.
